



Understanding COPIC's Premium Rates



Like other types of insurance, COPIC's premium rates are developed by analyzing data about past experience and current trends in order to estimate future risk and claims costs. Rates are determined on an annual basis and the prominent individual factors that influence your particular premium are medical specialty, geographic location, and claims history.

COPIC is committed to being transparent about our rate determination process and communicating any adjustments to our policyholders. It is important to remember that any premium percentage changes reflect base level adjustments and your policy discounts and other credits are applied to develop the actual premium amount.

What are the key factors that are analyzed to determine rates?

- Costs to defend against medical liability claims and lawsuits
- Claims frequency and severity (how often claims occur and total amount paid per claim)
- Medical and legal trends that may impact claims
- Actuarial projections for future claims

How does my medical specialty impact rates?

COPIC reviews specialty-specific factors that may impact claims such as geographic location of practice, procedures performed, and the frequency/severity of claims. These assessments help us to identify differences between specialties that are used in calculating premium rates.

Does the state where I practice impact rates?

Yes. Claims experience at the state and county level along with a state's medical liability environment are evaluated and influence one's premium rate.

What other factors influence rates?

In addition, rates are also influenced by each policy's limits of liability, who is covered under the policy, claims history, and policy maturity (how many years you have been with COPIC).

What should I consider when looking at rates versus actual premiums?

As noted before, discounts, distributions, and other elements are applied to develop the actual premium amount. Some of the common discounts COPIC offers include:

- Earning COPIC points through participation in educational activities
- Being a member of your state medical association/society
- Discounts for new physicians and part-time practice

HARDEN YOUR CYBER "ATTACK SURFACE"

Criminals exploit poor configurations, weak controls, and other poor cyber practices to gain initial access to a victim's system. The Cybersecurity & Infrastructure Security Agency (CISA) provides an excellent roadmap on how to protect your attack surface by identifying the commonly exploited controls and the best practices to mitigate them (www.cisa.gov/uscert/ncas/alerts/aa22-137a). By understanding these common attack vectors, you can reduce your chances of falling victim to ransomware and other cyber threats.

Malicious actors often exploit the following common weak security controls, poor configurations, and poor security practices to deploy the initial access techniques:

- Multifactor authentication (MFA) is not enforced.
- Incorrectly applied privileges or permissions and errors within access control lists.
- Software is not up to date.
- Use of vendor-supplied default configurations or default login usernames and passwords.
- Remote services, such as a virtual private network (VPN), lack sufficient controls to prevent unauthorized access.
- Strong password policies are not implemented.
- Cloud services are unprotected.
- Open ports and misconfigured services are exposed to the internet.

- Failure to detect or block phishing attempts.
- Poor endpoint detection and response.

Securing these pathways is essential to preventing a data breach. Here are some recommendations:

- Implement MFA on all remote access, email, and admin accounts.
- Develop a software and patch management program.
- Implement endpoint and detection response tools.
- Maintain rigorous configuration management programs.
- Give employees only the necessary resources and access to perform their tasks.
- Train employees to recognize phishing emails and other social engineering.

WHAT IS A FRAGMENTED HEALTH CARE ENVIRONMENT?

We all know that medical care is increasingly complicated. Physicians have sophisticated diagnostic and treatment paradigms that are augmented by tremendous technological advancements. This has resulted in patients who have several chronic medical conditions seeing an average of 16 different physicians a year. When you add the proliferation of free-standing urgent care centers, pharmacy clinics, citywide health screenings, and alternative care, the traditional model of primary care referring patients to specialists who then manage the outcome is rare. How can we keep track of what each medical professional is doing? As a practicing vascular surgeon in Denver for the past 27 years, these are issues that keep me up at night.

An additional layer of complication are the social determinants that affect a patient's visit. When a patient cannot afford the prescription, cannot figure out public transportation to the imaging center, or does not understand the language translation, important details can go undetected.

Further, our patients expect that their up-to-date medical information

from all providers is available to us. They can become understandably upset or confused by the system that fails to meet this expectation. We are frustrated by hunting down unavailable information, inadvertent duplicative test ordering, medication errors, and missed diagnoses. We worry about our patients' information that we cannot readily access or that we do not even know exists. This is what fragmentation looks like.

THE COPIC MEDICAL FOUNDATION'S PRIORITIES ARE FOCUSED ON REDUCING FRAGMENTATION IN CARE SETTINGS. AND FOR THIS, WE NEED YOUR HELP.

I am certain that there is an organization out there that can help overcome the perils of fragmentation. I suspect this organization will have a surprisingly simple concept, just like how Amazon started as a mere online bookstore and Tesla disrupted the concept of needing a big auto dealership showroom. Innovative changes can lead to surprising results.

I believe this organization may already exist, has the great idea, and needs

a place to test it out. It might serve a rural or urban environment, and may or may not be affiliated with a health system. Its focus might be pediatrics, women's health, or mental health and it may be domiciled anywhere in the country. These details aren't the important part.

What is important is that the COPIC Medical Foundation (CMF) wants to meet the people and organizations who have those ideas and are developing programs to address them. We want to do all we can to help eradicate the current fragmentation challenges in our health care environment.

CMF has financial resources to grant organizations on the cusp of innovation, and we'd like to serve as a catalyst for their work to maximize the impact on patient safety. Each November, we launch an RFP and select programs to receive grants that have a solid base and replicable solutions. Once they become a member of the CMF grantee cohort, we connect them with others to create a synergy of expertise and share their experiences. COPIC Medical Foundation: 2023 GRANT FUNDING

The COPIC Medical Foundation (CMF) works to improve health care outcomes through grant funding of:

- 1 Programs and initiatives that improve patient safety and quality of care or through systems changes and improvements.
- 2 Pilot programs that are designed to reduce medical errors.
- 3 Development and implementation of checklists and other tools to improve disease management and transitions in care.

2023 FOCUS AREA

Fragmentation Across Care Settings

For 2023, our grant funding will continue to focus on the issue of reducing fragmentation across care settings. A top concern in the field of patient safety, breakdowns in care from a fragmented health care system can lead to readmissions, missed diagnoses, medication errors, delayed treatment, duplicative testing and procedures, and reduction in quality of care leading to general patient and provider dissatisfaction. For CMF, contributing to a solution to this safety concern means supporting scalable or replicable solutions, focusing on the testing of new ideas or growing existing solutions, and then seeing avenues for larger application.

FUNDING CYCLE

CMF is accepting applications November 1, 2022 through January 13, 2023 for its 2023 cycle of grant funding.

CRITERIA

To be considered for funding, organizations must meet the following minimum criteria:

- Approach or program has demonstrated potential for uptake or replication by the health care community
- Organization is designated as a 501(c)(3) organization or has an identified fiduciary

DEADLINES AND APPLICATIONS

Grant applications are due January 13, 2023 by 5pm (Mountain Time). Applications can be emailed to: mhintze@copic.com. Applicants can expect to hear from CMF regarding potential support by March 15, 2023.

THE LEGISLATIVE LANDSCAPE

PREPARING FOR THE 2023 SESSION

A critical piece of COPIC’s legislative advocacy is meeting with state-level candidates to discuss our priority of improving medicine so that patients have access to safe, quality care. Through the summer and fall months, COPIC met with legislators about the issues that are vital to maintaining balance in Colorado’s health care environment. These meetings also provide opportunities to understand the candidates’ views on health care policy, engage in thoughtful discussions, and extend COPIC’s resources to inform their efforts. In addition, our Public Affairs team strives to offer informed, nonpartisan insight that considers both the challenges of medical providers and the concerns of patients.

COPIC’S SUPPORT FOR LEGISLATORS

Through candidate meetings, COPIC can identify those individuals who share our legislative priorities. In an effort to demonstrate support, COPIC financially contributes directly to their campaigns as well as sponsors non-coordinated positive campaign communications supporting their candidacy.

Each election, we ensure that the campaign communications we sponsor are positive and free of attacks on any candidate. COPIC will not contribute to the negative tone that seems to permeate the campaign season.

ELECTION SEASON 2022

In 2020, Colorado underwent a political redistricting process that redrew the lines of congressional and state legislative districts. This process created 36 new districts with open seats (22 House, 12 Senate). This election year, Colorado’s ticket of legislative incumbents and new candidates hit the campaign trail to make their case to constituents about why they are the right person to serve Colorado at the General Assembly in 2023.

Why does this matter? The candidates who prevailed in the general elections will go on to introduce, debate, and vote on policy that impacts the delivery of medicine in Colorado.

ELECTION RESULTS BREAKDOWN

COPIC is encouraged that many of the incumbents we support were re-elected to the legislature in addition to many new candidates that COPIC met with early in their candidacy to establish positive relationships. We remain optimistic that these legislators share our goal of improving access to safe, quality health care delivery.

Colorado entered the 2022 elections with the Democrats holding a majority in the Colorado Senate with 20 seats to 15 seats. Senator Kevin Priola made a last-minute party swap from Republican to Democrat, expanding the majority by one seat.

At the time of publication, Colorado’s State Senate and House of Representatives will remain in Democratic control. The Colorado State Senate saw the Democrats pick up three seats, expanding their majority to 23 (D) to 12 (R). The Colorado House saw Democrats pick up four seats, expanding their majority to 46 (D) to 19 (R). Incumbent Democratic governor Jared Polis won his re-election bid against Republican challenger Heidi Ganahl, and he will serve for the next four years.

LOOKING AHEAD

COPIC’s Public Affairs team continues to engage with our health care partners to stay in front of potential public policy topics as we head into the 2023 legislative session. From these engagements, we are not anticipating any legislation directed at Colorado’s longstanding tort reform.

The Colorado General Assembly is slated to convene for 120 days beginning on January 9, 2023 and adjourn on May 6, 2023. As always, COPIC will continue to monitor legislative activities with our partners at the Colorado Medical Society and Colorado Hospital Association.

The COPIC Points Program is one of the ways we partner with insureds to offer more than just traditional coverage. Our team works closely to identify educational resources that address issues relevant to your medical practice, which then allows us to offer customized support.

- Participation in the COPIC Points Program allows you to earn CME/CNE credit along with “points” that apply toward an annual premium discount of 10%.
- Attaining the 3 COPIC points needed for the discount can usually be completed in as little as three hours; there are also many options for COPIC to present at your practice or facility.
- Eligible physicians, allied health professionals/advanced practice providers, and insured facilities can participate in the program; new COPIC insureds receive the discount in their first year, but need to participate in subsequent years.

PLEASE NOTE: THE ANNUAL CYCLE FOR COPIC POINTS HAS CHANGED AND IS NOW NOVEMBER THROUGH OCTOBER; THE NEXT ANNUAL CYCLE TO EARN COPIC POINTS IS FROM 11/1/22 THROUGH 10/31/23.

Examples of the opportunities to earn COPIC points include:

- **Complete an on-demand course on your own schedule**—Choose from 40+ courses that cover topics such as specialty-specific trends, managing unanticipated outcomes, patient communications, and interactive case studies. *Access on-demand courses at www.callcopic.com/education*

- **Complete an on-site, virtual, or self-assessment to identify high-risk areas in your practice or facility**—Managed by specially trained nurses, COPIC’s Practice Quality Reviews, Facility Assessments, and Self Assessments offer an objective review based on evidence-based guidelines, and results help you improve your systems and address preventable risks.
- **Attend one of COPIC’s annual conferences**—Each year, we host our Symposium (physician/practice-focused) and Forum (facility-focused only facility/hospital policies qualify for points), which are opportunities to hear from nationally-recognized experts and COPIC team members on timely health care topics. *The 2023 Symposium will be held April 19-21, and the 2023 Forum will be held October 23-25.*
- **Participate in a 3Rs Program training**—COPIC’s industry-leading 3Rs Program helps physicians communicate with patients after an adverse outcome to address their needs, preserve the relationship, and prevent litigation. We offer a training that focuses on 3Rs disclosure principles and how to effectively utilize the program. *Contact Carmenlita Byrd for training information at cbyrd@copic.com or (720) 858-6131.*
- **Complete programs offered by other organizations**—COPIC will consider approving COPIC points for programs and seminars given by other organizations such as professional societies, medical societies, and hospital programs (pre-approval is required).
- **Service Plans for Systems and Large Groups**—For certain systems and large groups that meet criteria for professional review structures, organization for quality improvement, and a scheduled COPIC educational program curriculum, we offer a streamlined process to administer points.





THE LEGISLATIVE LANDSCAPE

PREPARING FOR THE 2023 SESSION

A critical piece of COPIC's legislative advocacy is meeting with our partners as well as state-level candidates to discuss our priority of improving medicine so that patients have access to safe, quality care. These meetings provide opportunities to better understand health care policy issues, engage in thoughtful discussions, and extend COPIC's resources to inform others. In addition, our Public Affairs team strives to offer informed, nonpartisan insight that considers both the challenges of medical providers and the concerns of patients.

A Focus on Non-Economic Damage Caps

Over the past two years, COPIC's focus, along with our partners, has primarily been on advancing a hard cap on non-economic damages in medical liability cases. Currently in Iowa, there is no cap on total damages including monetary losses such as past and future medical expenses, loss of past and future earnings, loss of use of property, costs of repair or replacement, and loss of employment or business opportunities. There is a \$250,000 "soft cap" on non-economic damages.

It has been COPIC's experience in states that do have a hard cap on non-economic damages, that the cost we must incur on our insured health care providers has stabilized and allowed predictability in a very unpredictable expense industry. Caps have also helped with the recruitment and retention of health care providers in the 28 states that have them, especially those professionals in high-risk specialties such as obstetrics and gynecology. While the effort has not been successful to date due to just a few votes, we are encouraged by Governor Kim Reynolds' commitment to the issue and the election results.

The Iowa Medical Society and Iowa Hospital Association have been working hard this election year to

educate candidates and incumbents on the importance of passing a cap on non-economic damage caps in medical liability cases. This important work provides us a new opportunity to pass legislation in 2023. For all of these reasons, we continue to focus our support toward the passages of this important legislation.

Election Season 2022

This year, Iowa's ticket of legislative incumbents and new candidates hit the campaign trail to make their case to constituents about why they are the right person to serve Iowa at the legislature in 2023.

Why does this matter? The candidates who prevailed in the elections will go on to introduce, debate, and vote on policy that impacts the delivery of medicine in Iowa.

Election Results Breakdown

Iowa entered the 2022 elections with the Republicans holding a majority in the State Senate and in the House of Representatives.

Election results show that Iowa's State Senate and House of Representatives will remain in Republican control. The Iowa State Senate saw the Republicans pick up two seats, expanding their majority to 34 (R) to 16 (D). The Iowa House

will remain Republican-controlled in 2023 with a 64 (R) to 36 (D) majority. Incumbent Republican Governor Kim Reynolds won her election bid and will serve for the next four years.

Looking Ahead

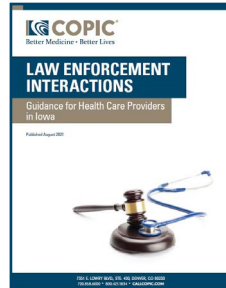

>>Law Enforcement Interactions

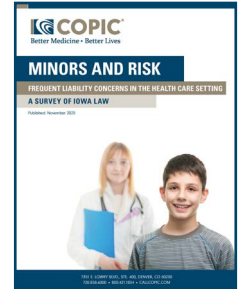

THE LEGISLATIVE LANDSCAPE

PREPARING FOR THE 2023 SESSION

A critical piece of COPIC’s legislative advocacy is meeting with our partners as well as state-level candidates to discuss our priority of improving medicine so that patients have access to safe, quality care. These meetings provide opportunities to better understand health care policy issues, engage in thoughtful discussions, and extend COPIC’s resources to inform others. In addition, our Public Affairs team strives to offer informed, nonpartisan insight that considers both the challenges of medical providers and the concerns of patients.

COPIC’s Support for Legislators

Through candidate meetings and coordination with our partners, COPIC’s team identifies those individuals who share our legislative priorities. To demonstrate support of their run for the Unicameral, COPIC financially contributes directly to their campaigns.

Election Season 2022

This year, Nebraska’s ticket of legislative incumbents and new candidates hit the campaign trail to make their case to constituents about why they are the right person to serve Nebraska at the Unicameral in 2023.

Why does this matter? The candidates who prevailed in the elections will go on to introduce, debate, and vote on policy that impacts the delivery of medicine in Nebraska.

Election Results Breakdown

COPIC is encouraged that many of the incumbents we support were re-elected to the legislature in addition to many new candidates that COPIC met with early in their candidacy to establish positive relationships. We remain optimistic that these legislators share our goal of improving access to safe, quality health care delivery.

While technically the legislative body is nonpartisan in Nebraska, party affiliations are well known. The Nebraska Unicameral entered the 2022 election season with the Republicans holding a majority in the legislature—32 seats to 17.

At the time of publication, election results show that the Nebraska legislature will remain in Republican control. Although the final partisan breakdown is still being determined, Nebraska Republicans are aiming for a 33-seat majority in order to overcome any attempts to filibuster legislation. A filibuster-proof majority, if achieved, could have a significant impact on policy discourse in 2023.

Looking Ahead

COPIC’s Public Affairs team continues to engage with our health care partners to stay in front of potential public policy topics as we head into the 2023 legislative session. From these engagements, our focus will be to support legislation directed at ensuring the long-term sustainability of the Excess Liability Fund.

Through conversations and meetings with our health care partners in Nebraska, COPIC’s Public Affairs team has identified a handful of potential topics that we expect to be at the forefront of the 2023 legislative session.

- Long-term sustainability of Nebraska’s Excess Liability Fund
- Access to abortion services
- Optometry scope of practice relating to SLT procedures
- Licensure of anesthesiologist assistants
- Telehealth payment parity.

The Nebraska Unicameral is slated to convene on January 4, 2023 and adjourn on April 18, 2023. As always, COPIC will continue to monitor legislative activities with our partners at the Nebraska Medical Association.

2022 COPIC HUMANITARIAN AWARD: **DR. KEVIN REICHMUTH**



COPIC and the Nebraska Medical Association (NMA) are proud to announce that Dr. Kevin Reichmuth, a pulmonologist in Lincoln, was chosen as the 2022 recipient of COPIC's Humanitarian Award. He is recognized for his commitment to making a difference in health care and was presented with the award at the NMA's annual meeting in September.

Dr. Reichmuth is a native of Columbus, Nebraska, and is passionate about health care advocacy and education. During the COVID-19 pandemic, he provided bedside clinic care to hundreds of patients impacted by the virus and volunteered as a medical expert to the local health department as well as the State Department of Public Health. Dr. Reichmuth provided community status updates to local physicians during weekly educational meetings and always volunteered to be interviewed by the media regarding the pandemic, offering health care advice based on his expertise.

Dr. Reichmuth received his medical degree from the University of Nebraska Medical Center and completed his residency and fellowship in Internal Medicine,

Pulmonary Medicine, Critical Care, and Sleep Medicine at the University of Wisconsin Hospitals and Clinics. He is board certified in all four specialties. He is currently the Medical Director of the Bryan Medical Center Sleep Center and the Columbus Community Hospital Sleep Laboratory, and also serves as the Tabitha Hospice Medical Director. In addition, Dr. Reichmuth is a Colonel in the Nebraska Army National Guard and has served for over 30 years with multiple deployments.

Dr. Reichmuth and his partners were one of the first Lincoln area clinics to volunteer to participate in the Lancaster County Medical Foundation's Medical Assistance program, which provides access to health care for approximately 1,500 uninsured individuals each year.

The COPIC Humanitarian Award was established in 2001 in honor Harold "Hal" E. Williamson. The annual award recognizes a physician going above the call of duty in the Nebraska health care community and provides a \$10,000 donation to be given to the health-related nonprofit of the recipient's choice. Dr. Reichmuth chose to donate the \$10,000 to the Lancaster County Medical Foundation's Medical Assistance Program.
